Clarification meeting and Site Visit for Tender procedure**

Recorded on November 15<sup>th</sup>, 2018 in Municipality of Novi Knezevac, on the occasion of the clarification meeting and site visit related to the implementation of Construction of bicycle path for project "SZEGED (SZŐREG) - NOVI KNEZEVAC BICYCLE ROAD CONSTRUCTION (PHASE 4)"

The clarification session started at 11.00 h.

On behalf of Municipality of Novi Knezevac, Mrs. Csilla Orosz Urbán, Project Manager held an introductory presentation to give an overview of the basic elements of the tender documentation.

Basic plan and obligations were presented:

Since the subject of the tender is the execution of works according to the existing technical documentation, upon the approval for the construction and upon the registration of the commencement of the works, the selected tenderer is responsible for the quality of the works performed. The technological wastewater treatment process is defined in the available technical documentation.

During the meeting, all attending potential tenderers were given the opportunity to a review the entire available technical documentation that is the subject of this tender (Volume 5.2). It was emphasized that potential tenderers are still enabled access to review project documentation according to the provisions of the tender, with prior announcement and agreement.
